DIRECTOR'S NOTE

Adapting Responsibly this Summer and into the Winter

Hopefully this is a good omen for the upcoming winter, but we are still optimistic for at least some sort of fall before winter truly hits.

It was great to have been open this summer for our participants who wanted to get out on some outdoor adventures. Not only did it make us more prepared to operate in this new era, but it was also apparent from the notes we received that it was a vital service for some of our participants. While our activity numbers were down due to the pandemic, we were really excited to give our participants the opportunity to empower and recharge themselves in the great outdoors. The policies and procedures we put in place appear to have been effective against COVID-19 transmission. I am thrilled to report that we have not seen any transmission to participants or staff due to running our summer program. As winter gets closer, the staff and board are working hard to update our COVID-19 policies and procedures to make them work in a wintertime setting.

Crested Butte Mountain Resort has released their plans for operating this winter which includes running the resort during their normal dates and opening terrain as usual. The plans also call for mask and distancing requirements (among other strategies) in order to minimize the risk of transmission



to the greatest extent possible for everybody participating at the resort. We are working diligently to ensure that our policies, procedures and operations mesh seamlessly with those of the ski area.

I am happy and grateful to report that our summer fundraising season went well. It has always amazed me how much support the ASC receives from our community and this summer was no different. We had a successful virtual

Crested Butte Open, followed by a great virtual Bridges of the Butte. This support ensures that our organization will be able to continue to offer our programming to participants, have the ability to give scholarships to those in need, and sustain our staff.

After being vetted against many fantastic non-profits from throughout Colorado, we were given its highest honor. RIDING ROUND AND ROUND

A special thanks to the Crested Butte News and Than Acuff for allowing us to reprint this article from the September 18, 2020 issue.

Michael Blunck stepped into his philanthropic role with the Adaptive Sports Center, first riding in the 24 Hours Bridges of the Butte eight years ago. But it was his involvement well before that when he was first hooked on helping out the organization. “I volunteered for Adaptive and when this guy showed up he was a paraplegic from the first Iraq war,” recalls

Blunck. “When I first saw him when he showed up I was afraid he was ready to take his own life. Five days later skiing with Adaptive I saw the Adaptive Sports Center had changed his life. That was a turning point for me.”

He gains additional inspiration every year in a little more personal manner from a friend who has a son with cerebral palsy.

“Every day they have challenges they have to face in life,” says Blunck. “In the ‘normal’ 24 Hours Bridges I challenge myself to try to somewhat understand what they deal with on a day to day basis. It makes me appreciate all that I have.”

This year COVID changed up the Bridges of the Butte event significantly from numerous participants riding 24 hours straight through, to an individual event over an extended period of time. Remarkably, Blunck managed to raise more money than ever before, earning the High Roller belt buckle for the sixth time.

“My original goal was \$6,000 but I got there pretty quick so I upped it to \$8,000 and almost raised \$9,000,” says Blunck.

Starting on Saturday, August 29, Blunck rode two hours a day for 13 out of 15 days straight on a “reverse” Bridges loop because of the one-way designation on Elk Avenue.

“I didn’t want to ride the wrong way on Elk Avenue and upset the cops,” explains Blunck. “They did yell at me some for blowing through stop signs.”

The two days he missed were for family on one day and then the September snow day. “I was going to ride but I had no idea the snow was going to stick to the roads,” says Blunck. “I thought I’d end up wiping out and wreck myself. The street slicks aren’t very good in snow.”



What the 24 Hours Bridges of the Butte will look like in the future is anyone’s guess and Blunck admits he’s not a fan of the 12-hour idea. But, that’s still not going to stop him.

“I don’t see myself stopping,” says Blunck. “Doing the night part is the fun part for me but I’m certainly not going to stop supporting the Adaptive Sports Center.”

PARTICIPANT SPOTLIGHT

ADAPT AND CONQUER

Shortly after Mike Murphy arrived at the Adaptive Sports Center in September with Operation BASH, an unexpected snowstorm deposited 10” of snow overnight, making their planned outdoor activities impossible. “Our group faced adversity with this storm and we figured out how to overcome it together,” recalls Mike. This would symbolize what would become a theme for the week – adapt and overcome – a theme Mike knows much about.

In 2018, Mike was deployed overseas in Greece. As his team was traveling across an airfield, the driver of the vehicle slammed on his brakes to avoid hitting some stray dogs. The unexpected jolt threw Mike’s head into the front seat with a loud crack. He immediately blacked out and suffered a concussion. When he came to, he could

barely see, but as he often says he “just decided to wing it,” and flew home to Albuquerque for Christmas, thinking his blurred vision was just temporary. He navigated through the airport by taking photos of the terminal, then putting the phone right up to his face so he could make his way to the right gate.

What he thought was temporary vision loss was eventually diagnosed as a traumatic brain injury. The swelling had damaged his optic nerve and sparked a genetic disease, resulting in an 80% loss of vision. He can only see shapes and shadows unless an object is within four inches of his eyes, as well as some peripheral vision.

Upon returning home, Mike’s vision loss didn’t stop him, and with the help of his girlfriend, Carrie Pressett, he decided once again to “wing it,” and let her guide him on several snowboard outings. “I felt like such a burden to her. I became frustrated and told her to leave me alone. I felt I was holding her back.”

It was during his time in the Soldier Recovery Unit in Fort Carson that he was introduced to adaptive sports. Mike recalls, “When I first started losing my sight I thought my life was over, that I would never feel like a normal person again. I was then introduced to adaptive sports and it completely changed my entire aspect on life.”

He had heard of adaptive programs, but never checked them out until he was invited on a trip to Crested Butte with Operation BASH. He decided to go on this particular trip because significant others were invited. Being able to

share the experience with Carrie “was an amazing experience for her as well, with all the struggles she goes through on a daily basis caring to my needs.”

Throughout the trip, there were many opportunities to get to know the other group members which made Mike realize that “there was hope again to be a normal person which was a freeing experience.” They all varied in age and were in different branches of the military. In addition to the other participants, Mike was profoundly touched by getting to know all of the ASC instructors and learning why they got into this line of work. “I sensed a true compassion that they all have for the adaptive community, which was priceless.”

Mike’s ultimate goal is to “get back into the fight” and he left with a clear goal of sharing his life-changing experience of independence and camaraderie through sport with other warriors with disabilities. “After this week, I discovered there are so many amazing people and programs available to make life normal again.” Mike plans to pursue a masters in social work with an emphasis in recreational therapy so he can teach others to adapt and conquer, just as he has learned to do.
