## ASC'S NEWEST PROGRAM MANAGER



What drew me to the ASC was not just the opportunity to work in adaptive sports, but to be part of a community that lives and breathes the values of adventure and accessibility. The ASC's commitment to breaking down barriers for outdoor recreation really resonated with me. I felt it from the moment I joined as a summer Marketing Intern back in 2016—this was the perfect place for me! During my internship I got to experience the ins and outs of the ASC. I was constantly drawn to programming, this led me to becoming a winter volunteer, where I had the chance to work directly with participants and witness the impact of adaptive sports firsthand. I then took my enthusiasm to Utah as an adaptive whitewater rafting guide before becoming a winter instructor at the ASC in 2018 and then onto a summer instructor, Program Coordinator, and now I will be stepping into the role of Program Manager this fall!

During my time as the Program Coordinator at the ASC, my role was both dynamic and deeply rewarding. I managed a range of logistics to ensure that each activity ran smoothly, and each participant's experience was both enjoyable and impactful. From coordinating the schedule and managing reservations to liaising with volunteers and participants, my goal was to ensure that our mission to enrich the lives of folks with disabilities through outdoor adventures was at the heart of everything we do. I am excited to continue working towards that goal as the new Program Manager.

For me, the ASC is more than just a job; it's about creating a supportive environment where every person has opportunities to grow and challenge themselves. I'm constantly inspired by the resilience and joy of our participants. Watching them grow and achieve their goals is a powerful reminder of why our work is so meaningful.

Being on the program team, I get to be involved in every part of a participant's experience, from the planning stages to their time out on the slopes. It's amazing to see someone who's nervous on their first day come back to the next season so excited and ready to crush more programming and new challenges.

One of the coolest parts of my role as Program Coordinator was teaching the activities we offer. Whether I was guiding a group on a mountain bike ride, rock climbing with someone from the community, or hiking with an individual participant, I loved the moments when I connected directly and witnessed those breakthrough experiences.

I also worked very closely with our volunteer crew. They're the heartbeat of our programs, bringing so much energy and compassion. I recruited, trained, and supported them, making sure each volunteer had what they need to succeed. I loved seeing the connections they built with participants, offering encouragement and support.

Being the Program Coordinator at the ASC allowed me to witness life-changing moments firsthand while collaborating with an incredible team of staff and volunteers. Every day presents new opportunities to support our participants, engage with our volunteers, and contribute to our mission.

It's the entire community that participates in and supports our programs that makes working at the ASC so fulfilling! I am so excited to contribute even more to the mission of the ASC as I take on a new role here as Program Manager this fall.

## PARTICIPANT SPOTLIGHT

# ALEX BITTLE

Alex Bittle and his mom, Pat, share an unbreakable bond. As a devoted mother, Pat has always made sure Alex, who has Down syndrome, has had every opportunity to grow and explore. Since 1994, those opportunities have included the Adaptive Sports Center (ASC), which has played a crucial role in Alex's journey, equipping him with the skills and experiences to support a lifetime of mountain adventures. Now, as Pat faces new challenges with her Alzheimer's diagnosis, the ASC has stepped up to provide support for both of them as their journey evolves.

For decades, Pat's foresight into the value of Adaptive lessons encouraged Alex to thrive in activities like skiing, snowboarding, biking and rock climbing. The late 1990s were transformative, as Alex mastered these sports, creating a solid foundation that allowed him to adventure alongside anyone who wanted to join him. Pat's investment in these lessons set the stage for Alex's enduring relationship with the outdoors and his community.

Doug, Alex's brother, shares the joy of seeing Alex succeed, particularly in the Special Olympics. Reflecting on Alex's achievements, Doug noted, "The Special Olympics provides an avenue for personal success for Alex. The program is really special because you can watch all [the participants] work towards goals and accomplishments and feel proud of themselves for what they've achieved." Doug's pride in Alex's accomplishments is evident, and he's deeply grateful to the ASC for helping Alex train for the Special Olympics along the way.

Doug often enjoys skiing or biking with Alex, but the ASC's program offers even more flexibility for their adventures. "It's great to have people you know and trust to help out," Doug shared. The trust and sense of community with the ASC instructors have been invaluable, allowing Alex the freedom to explore and trusting that he is always in good hands.

This summer has been especially rewarding for Pat who despite her Alzheimer's has been able to continue sharing in Alex's adventures thanks to the ASC. Being part of these outdoor experiences has brought happiness to Pat, whose joy is tied to Alex's success. Watching her son enjoy life with such passion and knowing he is out exploring and adventuring brings her peace throughout the day.

Advocating for equal access to outdoor recreation activities for people with disabilities is core to our mission. The ASC's true cost for one full-day lesson is over \$900, but with the help of grants and donations, we only charge \$95 for participants and their families.

The financial aspect of participating in the ASC has been a relief for Alex and Pat, as well. With both on fixed incomes, the program's affordable rate of \$95 ensures that they can continue participating with the ASC without the stress of financial strain.

This accessibility has allowed Alex to experience more of the world than he would have been able to otherwise.

For Pat and Alex, the ASC is not just a sports program—it's a lifeline that keeps them connected, fulfilled, and thriving. The opportunity to remain a unit, exploring the outdoors together, despite the challenges that life has thrown their way is nothing short of life-changing. The ASC has created a space where not only Alex can flourish, but where Pat's happiness can blossom as she continues to watch her son succeed in all his endeavors.

# MICHAEL BLUNCK'S 235-MILE RIDE

Michael Blunck recently completed an incredible feat of riding his townie bike, the Dragon Wagon, 235 miles from Craig Hospital in Englewood, Colorado all the way to Crested Butte. This unbelievable ride was in honor of the 20th annual Bridges of the Butte where Michael raised over \$80,000 for the ASC.

Over 10 days between August 30 and September 8, Michael rode 235 miles, climbed 16,048 feet in elevation, and had a total ride time of 30 hours and three minutes. His route went over several mountain passes, including Cottonwood Pass which has a total elevation gain of 5,265 feet. During the ride, his wife Lisa provided support by following him in their RV along the way, equipped with snacks, water, gear, and tools.



**I had raised close to \$60,000 when I started going up Cottonwood, thus I had 60,000 reasons to complete this ride. I made it around another switchback and I felt like I was getting stronger. I was being pushed up the hill by [my friend's son], Leo, and all the Adaptive participants.**



Michael has been a long-time supporter of the ASC through his fundraising efforts with Bridges of the Butte for the last 11 years. He started raising money for the ASC after witnessing the transformative power of adaptive sports when a paraplegic Iraq War veteran rediscovered joy and hope through adaptive skiing. Years later, Michael's friend's son Leo, born with cerebral palsy, added to his inspiration to support the ASC, as Leo thrives through local adaptive programs. By contributing to the ASC, people help individuals like Leo and others with physical challenges experience activities that many take for granted.

We'd like to give a huge congratulations and thank you to Michael Blunck for all of his tremendous support over the years. We are so grateful!

Advocating for independence and equal access to outdoor recreation activities for people with disabilities is core to our mission. Since our inception in 1987, we have accomplished this by offering our services at a reduced cost.

### \$95 FULL DAY LESSONS

Thanks to financial support from incredible donors and participants alike, we have reduced our existing subsidized full-day rate to \$95, which includes one-on-one instruction, equipment rentals and a lift ticket. We recognize that the cost to enjoy the great outdoors is commonly a barrier to participation, considering the added requirement of specialized equipment and professional instruction. If additional financial assistance is needed, we have an amazing scholarship fund.

## HELP SUSTAIN ACCESS FOR ALL PRICING

A typical full-day adaptive lesson costs the ASC roughly \$900. Thanks to the generosity of many, we are able to charge \$95 to provide this service. Those that are able to contribute beyond the lesson fee can “pay it forward” by adding a tax-deductible donation to their payment.
